COVID-19 Waiver, Release, and Assumption of Risk Form

You agree to not attend any Flowing Wells – Amphi Little League events if exhibiting any of the following new or worsening symptoms of possible COVID-19:

- Cough
- Shortness of breath or difficulty breathing
- Chills
- Muscle Pain
- Headache
- Sore throat
- New loss of taste or smell
- Diarrhea
- Feeling Feverish or a measured temperature greater than or equal to 100 degrees Fahrenheit
- Known close contact with a person who is lab confirmed to have COVID-19
- Currently living with someone experiencing symptoms of COVID-19

Temperature certification:

- I certify that I will take my temperature before arriving at the field and ensure it is less than 100.4° F. Duty to Inform:
- I will inform you if I knowingly come in contact with someone who tested positive within 14 days prior.
- I will inform you and not attend Winter Garden Little League activities for 14 days if I develop any of the above symptoms.
- If I test positive for COVID-19, I will not return to Winter Garden Little League activity without medical clearance.

Requirements While at FWCLL Fields:

- A mask will be worn at all times. This includes from entering the parking lot until exiting the parking lot, as well as spectator stands, dugouts, and areas adjacent to the fields. Children under 2 years old are exempt.
- Social Distancing of a minimum of 6’ is required in all areas. Family/household groups may sit together.
- Please comply with all request from FWCLL designated personnel.

The novel Coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Flowing Wells – Amphi Little League (“FWCLL”) has established preventative measures and policies to reduce the risk of spread of COVID-19. FWCLL cannot, however, guarantee that you, your child(ren), will not become exposed to and infected with COVID-19.

This Waiver and Release of Liability Relating to Coronavirus/COVID-19 (“Waiver and Release”) is effective for the entire 2021 FWCLL baseball/softball season, and encompasses any and all FWCLL events and activities (“FWCLL activities”).

I acknowledge that I have read each paragraph of the Waiver and Release.

I acknowledge and understand the contagious nature of COVID-19, and I voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in FWCLL activities, and that such exposure or infection may result in personal injury, illness, disability, or death.

I acknowledge and understand that I am agreeing to the terms set forth in the Waiver and Release, as consideration for my child(ren) being permitted to participate in FWCLL activities.

I acknowledge and understand that the risk of becoming exposed to or infected by COVID-19 while participating in FWCLL activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, volunteers, and all of FWCLL’s program participants and their families. I acknowledge and understand that it is impossible to eliminate the risk that my child(ren), and my family, become exposed to and infected by COVID-19 when participating in FWCLL activities.

I, for myself, my child(ren), my heirs, personal representatives or assigns, voluntarily agree to assume the risk that my child(ren), and my family, may be exposed to, and become infected by, COVID-19, when participating in FWCLL activities, and I agree to accept responsibility for any injury that my child(ren), or my family, may experience in connection with FWCLL activities, including, but not limited to, personal injury, disability, illness, and death. I voluntarily agree to release FWCLL and its officers, directors, agents, volunteers, coaches, and insurers (the “Released Parties”) from and against any and all liability, claims, demands, actions, damages, or causes of action of any kind arising from or related to my child(ren) or I being exposed to or infected by COVID-19 when participating in FWCLL activities.

Your signature below is an acknowledgement that you have read, understand, and agree to follow the safety guidelines. Your signature below is further acknowledgement that Flowing Wells- Amphi Little League and/or County/City officials have the right to remove you and/or your player from the fields complex for failure to follow the safety guidelines. Your signature below is further acknowledgement that FWCLL reserves the right in its sole discretion to suspend and/or cancel the season if circumstances warrant.
